December 1, 2011

The Quinault Indian Nation and the Bureau of Indian Affairs are working together to update the current Forest Management Plan (FMP) for the Quinault Reservation. As a stakeholder, you have an opportunity to provide input into the process by documenting how you use the natural resources on the Reservation, what benefit you derive from them, and how their management will impact you. Completing and returning the enclosed questionnaire is one of your opportunities to participate in the FMP update process.

Gathering this input is the first step towards completing a forest management plan that considers **ALL** of the forest resources (including timber, fish, wildlife, water quality, and cultural resources) and how their management will affect the people that use them. As either an enrolled member of the Quinault Nation or an allotment owner on the Quinault Reservation, we want to hear what your priorities are for the Reservation's forest resources. Please take a few minutes to answer the questions and return the completed form to Nancy Eldridge, QIN Planning Forester, in the envelope provided. You could also drop completed questionnaires in a box located in the lobby of the Quinault Division of Natural Resources (QDNR) building in Taholah.

Please note that for question #3 we have asked that you choose your three highest uses and for question #4 we have asked that you choose your top five priorities. If you select more than we have asked, we will not be able to use your input from those two questions.

In an attempt to reach as many stakeholders as possible, we have drawn contact information from several sources and so you may receive multiple mailings. Please disregard any duplicate questionnaires or pass them along to someone else. 5. **ROADS.** Reducing the amount of open roads on the Reservation would provide environmental benefits to fish and wildlife, and may also protect against trespass, poaching, vandalism, garbage dumping, etc. However, open roads do provide easier access to hunting and fishing areas.

6. **HARVEST RESTRICTIONS.** Do you believe that harvest restrictions on the Reservation should be more restrictive, less restrictive, or the same as timber harvest restrictions that our state, federal, and private neighbors are required to follow? Examples include restrictions around culturally and/or ecologically sensitive or important areas in an attempt to protect water quality and fish/wildlife habitat. Examples include buffers on streams and wetlands; special protection for floodplains, sensitive cultural or wildlife areas, etc.

7. **FOREST MANAGEMENT DEDUCTION (FMD).** Currently, 6% of net revenue from timber sales on allotments is held and invested back into the forest to pay for forest development activities such as reforestation and timber stand improvement. Most other Tribes withhold 10%. Would you be willing to increase the FMD from 6% to 10% to accommodate improvements in forest development?
